The State Election Commission, Telangana issued Notification vide reference 1st cited for preparation and publication of Ward wise Gram Panchayat Electoral Roll for casual vacancy to the office of 5th Ward of Marampally Gram Panchayat, Nandipet Mandal in Nizamabad District. The Final Electoral rolls will be published on 12.04.2021 w.r.t. 01.01.2021 as the qualifying date

While setting up of Polling Stations for elections to casual vacancy to the office of 5th Ward of Marampally Gram Panchayat, Nandipet Mandal in Nizamabad District, the election authorities concerned have to be followed the circular instructions already issued on setting up of Polling Stations by the TSEC vide Circular No.1461/TSEC-PR/2016, Dtd: 28.11.2016. Circular may be downloaded from the TSEC website i.e. tsec.gov.in.

The list of polling stations of the above mentioned vacancy shall be prepared and published based on the Electoral rolls will be published on 12.04.2021.

The list of Polling Stations of 5th Ward of Marampally Gram Panchayat, Nandipet Mandal in Nizamabad District is to be published by the Assistant District Election Authority & Mandal Parishad Development Officer, Nandipet Mandal after getting authentication from the Collector & District Election Authority, Nizamabad.

The list of polling stations shall be prepared and published **to the Casual Vacancy to the Office of 5th Ward, Marampally Gram Panchayat** as per the schedule given below for:

1. Preparation of draft list of polling stations by – 09.04.2021
2. Draft publication of list of polling stations on – 10.04.2021
3. Receipt of claims and objections – From 10.04.2021
to 11.04.2021
4. Meeting with representatives of Political Parties on – 11.04.2021
5. Disposal of claims and objections & suggestions by – 12.04.2021
6. Approval of Collector & District Election Authority
for list of polling stations on – 13.04.2021
7. Final publication of list of polling stations on – **14.04.2021**

The Collector and District Election Authority, Nizamabad is requested to see that the entire process is completed by **14.04.2021**.

The preliminary arrangements for the setting up of Polling Stations should be initiated forthwith. The Asst. District Election Authority & Mandal Parishad Development Officer, Nandipet Mandal should be entrusted with the work of identification of Polling Stations, preparation of list of Polling Stations, publication of draft and final list of Polling Stations. The District Collector, Nizamabad should obtain the list from the Assistant District Election Authority & Mandal Parishad Development Officer, Nandipet Mandal, scrutinize and approve them before their final publication. The Asst. District Election Authority & Mandal Parishad Development Officer, Nandipet Mandal should be instructed to physically inspect the building proposed for Polling Stations for conduct of election to the office of 5th ward, Marampally Gram Panchayat in Nandipet Mandal.
