Sub:- TSEC –PR – Elections to the Panchayat Raj Bodies – Setting up of Polling Stations for conduct of Election to the office of Sarpanch of Anthireddyguda Gram Panchayat of Nandigama Mandal in Rangareddy District based on Electoral Rolls will be published on 11.03.2023 w.r.t. 01.01.2023 as the qualifying date – Instructions issued – Reg.

The State Election Commission, Telangana issued Notification vide reference 1<sup>st</sup> cited for preparation and publication of Electoral Roll for the vacancy to the office of Sarpanch of Anthireddyguda Gram Panchayat, Nandigama Mandal in Rangareddy District. The draft electoral rolls will be published on 06.03.2023 and the Final Electoral rolls will be published on 11.03.2023 w.r.t. 01.01.2023 as the qualifying date.

While setting up of Polling Stations for elections to vacancy to the office of Sarpanch of Anthireddyguda Gram Panchayat, Nandigama Mandal in Rangareddy District, the election authorities concerned have to follow the circular instructions already issued on setting up of Polling Stations by the TSEC vide Circular No.1461/TSEC-PR/2016, Dtd: 28.11.2016. The said Circular may be downloaded from the TSEC website (i.e. tsec.gov.in). Since the election is for Sarpanch post only, there is no need to set up ward – wise polling stations. The polling stations have to be set up for every **500** voters positively.

The draft list of polling stations of the above mentioned vacancy shall be prepared and published based on the draft Electoral rolls to be published on

06.03.2023. However the final list of polling stations shall be published based on the final publication of Electoral Rolls to be published on 11.03.2023.

The list of Polling Stations of Sarpanch, Anthireddyguda Gram Panchayat of Nandigama Mandal in Rangareddy District are to be published by the Assistant District Election Authority & Mandal Parishad Development Officer, Nandigama Mandal after getting authentication from the Collector & District Election Authority, Rangareddy.

The list of polling stations shall be prepared and published **to the Vacancy of the Office of Sarpanch, Anthireddyguda Gram Panchayat** as per the schedule given below:

The Collector and District Election Authority, Rangareddy is requested to see that the entire process is completed by **14.03.2023**.

The preliminary arrangements for the setting up of Polling Stations should be initiated forthwith. The Asst. District Election Authority & Mandal Parishad Development Officer, Nandigama Mandal should be entrusted with the work of identification of Polling Stations, preparation of list of Polling Stations, publication of draft and final list of Polling Stations. The District Collector, Rangareddy should obtain the list from the Assistant District Election Authority & Mandal Parishad Development Officer, Nandigama Mandal, scrutinize and approve them before their

final publication. The Asst. District Election Authority & Mandal Parishad Development Officer, Nandigama Mandal should be instructed to physically inspect the buildings proposed for Polling Stations for conduct of election to the office of Sarpanch, Anthireddyguda Gram Panchayat in Nandigama Mandal.
