The Collectors & District Election Authorities are requested to see that the process is completed by **14.04.2021**.

The preliminary arrangements for the setting up of Polling Stations should be initiated forthwith. The Commissioners of Municipalities and Municipal Corporations should be entrusted with the work of identification of Polling Stations, preparation of list of Polling Stations, Publication of draft and final list of Polling Stations. The District Collectors should obtain the Polling Stations lists from the Municipal Commissioners concerned scrutinize and approve them before their final publication. The Returning Officers of Municipalities/ Municipal Corporations concerned should also be instructed to physically inspect the buildings proposed for Polling Stations of the Municipalities/ Municipal Corporations.

The Polling Station wise Electoral Rolls (without photos) of the Municipalities/ Municipal Corporations shall also be published in the web portal of the Municipalities/ Municipal Corporations concerned and TSEC on 11.04.2021. Circular instructions issued in this regard vide Ref. No.2834/TSEC-ULBs/2019-1, Dtd:28.11.2019 shall be followed.
