Sub:- TSEC - Elections – Ordinary Elections to ULBs,2019 – Publication of list of Polling Stations – Polling stations were not published in certain Urban Local Bodies due to court cases - Schedule for publication of polling stations of ULBs which did not published earlier due to court cases – Reg.

1. In the reference 1<sup>st</sup> cited, the Commission issued revised schedule for preparation and publication of ward wise polling stations of Municipalities. As per the schedule indicated therein, the draft list of polling stations was to be published on 17.7.2019, conduct of meeting with the representative of political parties was on 17.7.2019 and final publication of list of polling stations was on 21.7.2019.

2. Due to filing of Writ petitions in the Hon'ble High Court, as per the schedule indicated in the reference 1<sup>st</sup> cited-,

1. Some Municipalities did not publish draft list of polling stations
2. Some Municipalities published draft list of polling stations but, did not conduct political parties meeting and not published final list of polling stations.
3. Some Municipalities published draft list of polling stations, conducted political parties meeting, but not published final list of polling stations.

3. In the reference 2<sup>nd</sup> cited, the Director of Municipal Administration and Election Authority, requested the Commission, to issue schedule for publication of polling stations of Municipalities which could not publish earlier due to court cases.

4. In view of the above, the following schedule is issued for preparation and publication of ward wise polling stations of only those Municipalities which did not publish earlier as per schedule given in the reference 1<sup>st</sup> cited.

7	Approval of the District Election Authority for the list of Polling Stations of Municipalities concerned on	21.08.2019
8	Final publication of the list of Polling Stations of Municipalities concerned on	23.08.2019

5. The Municipal Commissioners concerned shall start the process of publication of polling stations as per the above schedule only from the stage where it was stopped as mentioned in paragraph 2 above.

6. The Collectors & District Election Authorities are requested to see that the process is completed by 23.08.2019 as per schedule indicated above.

7. If there is any change in polling areas after publication of final list of polling stations due to modification of any ward boundaries the Collector and District Election Authority is authorized to alter the polling areas accordingly.

8. The Director of Municipal Administration and Election Authority shall monitor the process of publication of polling stations and ensure that it is completed as per the schedule given by the Commission.
