ORDER

WHEREAS, the Commission has allotted Common Symbol "Bat" to Jana Shankhaaraavam Party vide Order No.3059/TSEC-L/2019, dated 08.01.2020 under the provisions of the paragraph 6A in Part-III of Symbols Order, 2018 as amended upto 30.12.2019.

AND WHEREAS, as per paragraph 6A in Part-III of Symbols Order, 2018, after allotment of common symbol, if the party fails to contest in 10% of total seats in any subsequent ordinary elections, the party will lose its common symbol for further elections and also cannot apply afresh till the completion of five years period from the date of allotment of common symbol and forfeit the deposit amount.

AND WHEREAS, the ordinary elections to the Municipalities and Municipal Corporations were notified vide Notification 3038/TSEC-ULBs/2019, dtd: 07.01.2020, poll was conducted on 22.01.2020 and results were declared on 25.01.2020, in case of Karimnagar Municipality were notified vide Notification 3038/TSEC-ULBs/2019-1, dtd: 9.01.2020, poll was conducted on 24.01.2020 and results were declared on 27.01.2020.

AND WHEREAS, the total number of offices (Wards) to which elections were held in the above said elections to ULBs is (3112) and 10% of the total number of offices is (311).

AND WHEREAS, after verification of the information in the TSEC Web Portal (Te-Poll Software), it was found that, Jana Shankhaaraavam Party has not set up any candidates in ordinary elections to Municipalities and Municipal Corporations.

AND WHEREAS, the Commission vide Lr.No.3059/TSEC-L/2019-1, dated 24.06.2020 requested the President, Jana Shankhaaraavam Party to send the details

of candidates set up by their party in ordinary elections to Municipalities and Municipal Corporations immediately to the Commission within (7) days from the date of receipt of said letter.

AND WHEREAS, Sri Pardipur Narsimha, President of Jana Shankhaaraavam Party vide his letter dated:06.07.2020 has stated that, their Party could not contest in the ordinary elections to Municipalities and Municipal corporations, 2020 held on 22.01.2020 as they could not find suitable candidates to contest in 10% seats in the elections as their Party is newly registered with TSEC on 27.11.2019.

NOW, THEREFORE, as per the as per paragraph 6A in Part-III of Symbols Order, 2018 as amended upto 30.12.2019 read with the State Election Commission Order No.3059/TSEC-L/2019, dated:08.01.2020, the Commission hereby declares that, Jana Shankhaaraavam Party has lost the common symbol "Bat" allotted to the Party and forfeited the deposit amount and ineligible to apply afresh for a common symbol for remaining period of five years ending with 07.01.2025 for failure to set up of 10% candidates in ordinary elections to Municipalities and Municipal Corporations held in January, 2020.
