The State Election Commission, issued Notifications vide reference 1st, 2nd and 3rd cited for preparation and publication of electoral rolls of Ward Member casual vacancies in Municipalities / Municipal Corporations indicated in the Annexure appended to this Circular for conduct of elections to them. The final photo electoral rolls were published on 21.04.2022. The final photo electoral rolls of Ward No.7 of Korutla Municipality in Jagitial district will be published on 30.04.2022.

The next step in the process is publication of polling stations. Circular instructions were already issued by the Commission on the Setting up of Polling Stations for conduct of elections to the office of Ward Member in Municipalities and Municipal Corporations vide reference 4th cited (copy enclosed). The said circular is also available in the TSEC website tsec.gov.in.

The final list of Polling Stations of Ward member casual vacancies shall be prepared and published as per the schedule given below based on Ward final Electoral Rolls published on 21.04.2022 and to be published on 30.04.2022.

The District Collectors concerned should obtain the list of Polling stations from the Municipal Commissioners concerned for their scrutiny and approval before their final publication. The Returning Officers of Municipalities/Municipal Corporations concerned should also be instructed to physically inspect the buildings proposed for Polling Stations.

The Polling Station wise Electoral Rolls (without photos) of the Ward shall also be published in the web portal of the Municipalities/Municipal Corporations concerned and TSEC website by 31.05.2022. Circular instructions issued in the 4th cited shall scrupulously be followed.
