Sub: TSEC – Elections – Ordinary Elections to Gram Panchayats, 2019 – Election Notification issued for conduct of Ordinary Elections to Gram Panchayats in the State – Publication of GPERs with supplements 1 & 2 along with Election Notice by Returning Officers – Reg.

It has come to the notice of Commission that, some of the Returning Officers have not published supplement-2 to GPERs along with election notice to-day in 1st phase Gram Panchayats.

In this regard your attention is invited to the references cited. In the reference 1st cited, the Chief Electoral Officer, GAD was requested to issue instructions to all Assembly Constituency Electoral Registration Officers to continue continuous updation process duly disposing the claims and objections filed with the EROs till the date of Gram Panchayat Election Notification to be issued by State Election Commission. In the reference 2nd cited, the Chief Electoral Officer, Telangana has instructed all the District Collectors to see that all the claims and objection received upto 26.12.2018 through online/offline should be disposed it by 31.12.2018 scrupulously in connection with the ensuing elections to Gram Panchayats in the state and also requested to furnish hard copies of those supplements of ACERs w.r.t. 01.01.2018 to the concerned DPOs.

Hence all the Assembly Electoral Registration Officers may be instructed to furnish hard copies of these supplements of ACERs w.r.t. 01.01.2018 in PDF format only, where the photos of the electors are printed (it is noticed that some of the EROs are issuing supplement in Excel format without photos).

Further these supplements have to be segregated Gram Panchayat wise and ward wise and attached to the GPERs as supplement-2 and published invariably along with Election Notice by the Returning Officers and also to be supplied to political parties reserved with a symbol without fail.
