The State Election Commission, Telangana issued Notification in the reference 1<sup>st</sup> cited for Preparation and Publication of Electoral Rolls of Wards of Greater Hyderabad Municipal Corporation and schedule of events thereof.

The final Electoral Rolls of the said ward will be published on 13.11.2020.

In the reference 2<sup>nd</sup> cited, the Commission issued notification approving the list of officers specified therein for appointment of RO and AROs for conduct of ordinary elections to Greater Hyderabad Municipal Corporation.
