ORDER:

In the G.O. 1<sup>st</sup> read above, Government have issued the Andhra Pradesh Municipal Corporations (Reservation of seats) Rules 1995 and adopted to the State of Telangana vide G.O. 2<sup>nd</sup> read above.

2. The Government vide Act.No.20 of 2020 have made certain amendments to section 5 of the Greater Hyderabad Municipal Corporation Act, 1955, for reserving the wards by rotation after 'two consecutive terms'. Accordingly, the Commissioner, GHMC, Hyderabad has proposed the amendment to Rule 8 of the Telangana Municipal Corporations (Reservation of seats) Rules, 1995 in consonance with the amendment made to the GHMC Act, 1955 .

3. The Government after careful examination of the matter have decided to amend the Rule 8 of the Telangana Municipal Corporations (Reservation of seats) Rules 1995 in consonance with the amendment made to the GHMC Act, 1955.

4. Accordingly the following Notification will be published in an Extra-Ordinary Issue of Telangana Gazette dated: 31.10.2020.

NOTIFICATION

In exercise of the powers conferred by section 585 read with sub-section (2) of section 5 of the Greater Hyderabad Municipal Corporation Act, 1955, the Government of Telangana hereby makes the following amendments to the Telangana Municipal Corporations (Reservation of seats) Rules, 1995 as amended from time to time:-

In the said Rules, for Rule 8 along with the proviso thereunder, the following shall be substituted, namely:-

"8 Rotation of Seats:- The reservation of wards for Scheduled Tribes, Scheduled Castes, Backward Classes and Women shall remain in force for two consecutive terms treating the reservation made to these categories held during GHMC Elections in 2016 as first term of rotation. The Municipal Commissioner shall maintain a Register for this purpose in Form-I :

Provided that whenever an exercise for division of Municipal Corporations into wards under the Telangana Municipal Corporation (Delimitation of wards) Rules, 1996, has been taken up, the cycle of reservation of seats shall start afresh."

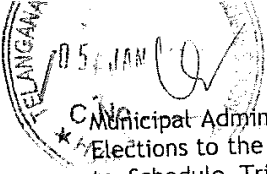


