Whereas, the Telangana State Election Commission issued Notification in reference No. 195/TSEC-PR/2018, dated: 20.04.2018 for preparation and publication of Ward wise Photo Electoral Rolls of Gram Panchayats duly adopting latest Assembly Electoral Rolls published w.r.t. 01.01.2018 as the qualifying date by the District Panchayat Officers concerned for conduct of Ordinary Elections to Gram Panchayats in the State. As per the given schedule, final Ward-wise Gram Panchayat Electoral Rolls were published on 17.05.2018.

And whereas, all the District Panchayat Officers in the State have reported that, the Ward wise Gram Panchayat Photo Electoral Rolls were published in all the Gram Panchayats and copies of the GPERs were also supplied to all the recognized political parties in their Districts. The GPERs also hoisted in Telangana State Election Commissions' web portal.

And whereas, after publication of GPERs, the Collector and District Election Authorities of Mahabubnagar, Nalgonda, Warangal Rural, Ranga Reddy and Vikarabad and the District Panchayat Officers of Jagitial, Jayashanker Bhupalpally, Karimnagar and Rajanna Siricilla Districts have reported that, during this exercise some mistakes have taken place in some Gram Panchayats while merging the voters to the concerned Gram Panchayats from Assembly Electoral Rolls and requested the State Election commission to accord permission to rectify the mistakes and also permit them re-publish the Ward-wise Photo Electoral Rolls of those Gram Panchayats duly reflecting the defects.

And whereas, after examining the issue carefully, the State Election commission considered the request for rectification, rearrangement and republication of Electoral Rolls of those Gram Panchayats where mistakes were occurred.

Now, therefore, in exercise of the powers conferred under Article 243-K of the Constitution of India read with Sections 10, 11 and 12 of Telangana Panchayat Raj Act, 2018, the State Election Commissioner, Telangana hereby, directs the District Panchayat Officers of Jagitial, Jayashanker Bhupalpally, Karimnagar, Nalgonda Mahabubnagar, Rajanna Siricilla, Ranga Reddy, Vikarabad and Warangal Rural Districts to rectify the defects, re-arrange and republish photo electoral rolls of the

Gram Panchayats indicated in the Annexure appended as per the schedule given below, duly indicating the Ward division as required under Rule 5 of the Preparation and Publication of Electoral Rolls Rules, 2018 in Form I thereof as per the procedure mentioned in Section 11 (4) of the Telangana Panchayat Raj Act, 2018 –
