Whereas, in reference No. 09/TSEC-PR/2022, dated: 29.03.2022 the Telangana State Election Commission issued Notification for preparation and publication of Ward wise Electoral rolls of Gram Panchayats having ordinary and casual vacancies in Gram Panchayats and also of Gram Panchayats having casual vacancies of MPTCs and ZPTC including the following casual vacancies.

1. Ward-7, ToshamTanda Gram Panchayat, Gudihathnoor Mandal of Adilabad District

And whereas, after issue of notification, in Lr.No.267/K2.Pts/2019, dated 01.04.2022 the DPO Adilabad, in Lr.No.80/A1.Pts/2022, dated 31.03.2022 DPO Mancherial, in Lr.Roc.No.3456/2019-B1(Pts), dated 31.03.2022 DPO Ranga Reddy, in Lr.No.946/2022-B5(Pts), dated 31.03.2022 DPO Nalgonda, email of DPO Mahabubnagar dated 04.04.2022 and CEO, Jangaon information of Hon'ble High Court order dated 08.11.2021 in IA No.2 of 2021 in WP No.8441 of 2021 filed by SmtKommu Sujatha, brought it to the notice of State Election Commission stating that, the above vacancies are struck in legal entanglements for the reasons indicated in their letters and also double entry and requested the State Election Commission to delete the above said casual vacancies from the Electoral publication notification No.09/TSEC-PR/2022, dated: 29.03.2022.

And whereas, the Commission examined the request of the DPOs and CEO and decided to issue an Errata to the Notification No.09/TSEC-PR/2022, dated. 29.03.2022 to delete the above mentioned vacancies from the notification.
