Whereas, as per the provisions of the GHMC Act, 1955, and rules relating to conduct of elections issued there under, elections to the office of Member of GHMC are conducted on party basis.

Whereas, certain forms were prescribed under Telangana Municipal Corporations (Conduct of election of members, Election expenses and election petitions) Rules, 2005 issued in G.O. Ms. No. 713, Municipal Administration an Urban Development (Ele.II) dated 21.7.2005, for being used in elections to the office of Member of GHMC.

And whereas, the Form –VI (Notice of Nomination) and Form –VIII (List of validly nominated candidates) prescribed under the above said rules for the purpose of recording of list of nominations received and list of validly nominated candidates are not compatible for conduct of elections on party basis as column for indicating party affiliation of candidate is not provided therein.

Now, therefore, in exercise of the powers conferred by Article 243-K and 243-ZA of the Constitution of India read with section 9 and 10 of GHMC Act, 1955, the State Election Commission, hereby, modifies the Form –VI (Notice of Nomination) and Form –VIII (List of validly nominated candidates) to be used for recording of list of nominations received and list of validly nominated candidates by adding a column for indicating party affiliation of candidate therein as shown in the Forms appended to this Notification.
