In exercise of the powers conferred under Section 196 and 197 and Sub-section (9) of Section 15 of Telangana Panchayat Raj Act, 2018 and read with second and third provisos of Rule 3(1) and 7 of Telangana Panchayat Raj (Conduct of Elections to Upa-Sarpanch of Gram Panchayat) Rules, 2018, the State Election Commissioner, Telangana, hereby, directs the District Panchayat Officers of Nalgonda and Medchal Malkajgiri Districts to authorize a person who shall be not below the rank of Revenue Inspector to conduct election to the **casual vacancies in the office of Upa-Sarpanch of (i) Cheekatimamidi Gram Panchayat of Munugode Mandal (ii) Guntukagudem Gram Panchayat of Nidamanoor Mandal in Nalgonda district and (iii) Kolthur Gram Panchayat of Muduchinthalapalli Mandal in Medchal Malkajgiri district** in accordance with the procedure laid down in the said rules and specifies the schedule for the casual election to the said office in Annexure appended to this Notification.
