In exercise of the powers conferred under Section 196 and 197 and Sub-section (9) of Section 15 of Telangana Panchayat Raj Act, 2018 and read with second and third provisos of Rule 3(1) and 7 of Telangana Panchayat Raj (Conduct of Elections to Upa-Sarpanch of Gram Panchayat) Rules, 2018, the State Election Commissioner, Telangana, hereby, directs the District Panchayat Officers of Khammam and Yadadri Bhuvanagiri Districts to authorize a person who shall be not below the rank of Revenue Inspector to conduct election to the **casual vacancies in the office of Upa-Sarpanch of (i) Puvvada Nagar Gram Panchayat of Raghunadhapalem Mandal & (ii) Ayyavarigudem Gram Panchayat of Yerrupalem Mandal in Khammam district and (iii) Kankanalagudem Gram Panchayat of Narayanpur Mandal in Yadadri Bhuvanagiri district** in accordance with the procedure laid down in the said rules and specifies the schedule for the casual election to the said office in Annexure appended to this Notification.
