In exercise of the powers conferred under Articles 243-K and 243-ZA of the Constitution of India, read with Sections 9, 10 and 12 of the Greater Hyderabad Municipal Corporation Act, 1955 (Act II of 1956) and Telangana Municipal Corporations (Preparation and Publication of Electoral Rolls) Rules, 2001, issued thereunder the State Election Commissioner, Telangana, hereby, notifies **11.04.2021** as the date for Publication of Photo Electoral Rolls of the **Ward No. 18, Lingo jiguda of Greater Hyderabad Municipal Corporation** and the Electoral Rolls shall be published along with notice in Form-I prescribed under the said rules duly following the schedule below:

Under Section 12 (1) of the Greater Hyderabad Municipal Corporation Act, 1955 and Rule 3 & 5 of the said Rules, the State Election Commissioner, Telangana hereby, authorizes the concerned Deputy Commissioner of Greater Hyderabad Municipal Corporation for Preparation and Publication of the Electoral Rolls of Ward No.18, Lingo jiguda of GHMC. The person so authorized

shall prepare the Electoral Rolls as specified under Rule 3 of the said Rules duly adopting the latest Assembly electoral rolls published with reference to 01.01.2021 as the qualifying date and publish them as required under Rule 5 of the said Rules along with Notice in Form-I specified thereunder. The Electoral Data pertaining to L.B.Nagar Assembly Constituency is available in the "Te-Poll Software".

Under Rule 4 of the said rules, the State Election Commissioner, Telangana also hereby directs the Deputy Commissioner of Greater Hyderabad Municipal Corporation, Circle-4 to prepare the electoral rolls of the Ward No. 18, Lingojiguda in the same format and language /languages as the Assembly electoral rolls. The details of the polling areas shall be indicated on the title page.
