NOTIFICATION

WHEREAS, in reference No. 482/TSEC-PR/2021-13, dated: 14.02.2023, the State Election Commission issued a Notification for conduct of casual election to the office of President of Midjil Mandal Praja Parishad in Mahabubnagar district;

AND WHEREAS, the Chief Executive Officer, ZPP Mahabubnagar and Addl. District Election Authority, Mahabubnagar has reported to the State Election Commission that, the election to the office of President of Midjil Mandal Praja Parishad remained unfilled due to lack of quorum in the meetings convened earlier i.e., on 27.02.2023 and 28.02.2023 in pursuance of notification No. 482/TSEC-PR/2021-13, Dated: 14.02.2023 for the purpose of holding election of President Midjil Mandal Praja Parishad;

AND WHEREAS, sub-rule (2) of Rule 9 of Rules relating to Telangana Panchayat Raj [Conduct of Elections to Member, Co-opted, President and Vice-President of Mandal Praja Parishad and Members, Co-opted, Chairperson and Vice-Chairperson of Zilla Praja Parishad Rules, 2018 issued in G.O.Ms.No. 27, PR & RD (PTS.III) Dept., dtd: 19.05.2018 (as amended)] stipulates that, "where the Election of President or Vice-President of MPP could not be conducted in the first two meetings convened for the purpose, for want of quorum, the President or Vice-President of MPP shall be elected in the subsequent meeting or meetings convened for this purpose from among the members present without insisting for quorum".

NOW THEREFORE, in exercise of the powers conferred by Article 243-K of the Constitution of India and Sections 196 and 197 of Telangana Panchayat Raj Act, 2018 (Act No. 5 of 2018), and Sub-Rule (2) of Rule 9 of Rules relating to the Telangana Panchayat Raj Conduct of election of Member, Co-opted, President and Vice-President of Mandal Praja Parishad and Members, Co-opted, Chairperson and Vice-Chairperson of Zilla Praja Parishad Rules, 2018 issued in G.O.Ms.No. 27, PR & RD (PTS.III) Dept., dtd: 19.05.2018 (as amended), the State Election Commissioner,

Telangana, hereby, directs the Collector and District Election Authority of Mahabubnagar district to authorise a Gazetted Officer of the Government **to conduct election to the casual vacancy of President of Midjil Mandal Praja Parishad in Mahabubnagar district** in accordance with the procedure laid down in the said rules and specifies the schedule for the election to the said offices in the Annexure appended to this Notification.

NOTE: In the event of a vacancy in the office of an elected member of Mandal Praja Parishad occurs for any reason after the issue of President, Mandal Praja Parishad casual election notification by the State Election Commission, the election to the office of President shall not stalled and shall be conducted as per the schedule.
