The State Election Commissioner, Telangana further, hereby, authorizes the Municipal Commissioner of Korutla Municipality under Sub-section (1) of Section 195-A of Telangana Municipalities Act, 2019 and Rule 3 and 5 of the said Rules for Preparation and Publication of Photo Electoral Rolls (MERs) of Ward No. 07 of Korutla Municipality in Jagitial District duly adopting latest Assembly Constituency Electoral Rolls (ACERs) in toto. Published with reference to 01.01.2022 as qualifying date.

Under Rule 4 of the said Rules the State Election Commissioner, Telangana also hereby directs that, Municipal Electoral Rolls of the Ward No. 07 of Korutla Municipality shall be prepared in the same format and language / Languages as Assembly Electoral Rolls. The details of polling areas shall be indicated on the title page of the ward Municipal Electoral Rolls.

After publication of ward Electoral Rolls on **30.04.2022**, any inclusions, deletions or corrections if any ordered in the ACERs under continuous updation U/s 22 or 23 of RP Act, 1950 **upto the date of Election Notification** under Section 195-A of Telangana Municipalities Act, 2019, shall be obtained by the Commissioner, Korutla Municipality from the ERO concerned and shall be carried out in the Electoral Rolls of the said ward till the date of election Notification issued by the State Election Commission.
