In exercise of the powers conferred under Article 243-K of the Constitution of India read with Section 11 of Telangana Panchayat Raj Act, 2018 Telangana Panchayat Raj (Preparation and Publication of Electoral Rolls) Rules, 2018, issued thereunder, the State Election Commissioner, Telangana, hereby, directs all the District Panchayat Officers in the State, to prepare and publish the Photo Electoral Rolls on **27.03.2019**, of all the Gram Panchayats, duly adopting the latest Assembly Photo Electoral Rolls in *toto* published on 22.02.2019 with reference to 01.01.2019 as the qualifying date, duly indicating the Ward division as required under Rule 5 of the said rules in Form I thereof and duly following Section 11 (4) of Telangana Panchayat Raj Act, 2018 and the Published Gram Panchayat Electoral Rolls shall be arranged Territorial Constituency wise of the Mandal Praja Parishad and Zilla Praja Parishad by the MPDO of the MPP and Chief Executive Officer of the ZPP as the case may be and shall be kept open for inspection by displaying it in the offices of the Mandal Praja Parishad and Zilla Praja Parishad concerned as stipulated under Rule 7 and 8 of Rules relating to Telangana Panchayat Raj (Preparation and Publication of Electoral Rolls) Rules, 2018 as per schedule given below –
