Whereas, in reference no. 621/TSEC-PR/2019, Dtd: 12.02.2019, the Telangana State Election Commission issued a Notification for conduct of elections to certain offices of Sarpanch and Ward Member of Gram Panchayats which remained unfilled in the ordinary elections due to various reasons including the following offices –

And Whereas, after issue of Notification, certain the District Panchayat Officers reported to State Election Commission to change vacancies due to erroneous report sent earlier. The details are as follows:

No. DPO/A1/Misc/0052/2019-A1, Dtd: 13.02.2019 to the State Election Commission informing that, the vacancy in the office of Sarpanch, Gurjal GP of Maganoor Mandal was erroneously reported to the Commission and requested to change the Mandal of the said vacancy as Krishana Mandal in the said Notification.
