Whereas, in reference No. 1553/TSEC-PR/2019, dated 20.04.2019, the State Election Commission issued Notification for conduct of Ordinary Elections to MPTCs and ZPTCs in three phases in the State.

And whereas, the MPTC Alwal of Mirdoddi Mandal in Siddipet District is notified for election in Phase-I.

And whereas, as per the election schedule notified in the Annexure-I appended to the Notification No. 1553/TSEC-PR/2019, dated 20.04.2019, the date of poll of MPTCs and ZPTCs notified in Phase-I of election is from 7.00 A.M to 5.00 P.M on 06.05.2019.

And whereas, in Lr.No.C3/1819/Alwal/2019, dated 06.05.2019, the Collector & District Election Authority, Siddipet District reported that, 21 ballot papers having Serial No.2020 to 2040 and another 21 ballot papers having serial nos. 2270 to 2290 of Andhey MPTC were mixed in the ballot paper bundle Nos.1 and 6 of polling station No.50 of Alwal MPTC. The Presiding Officer of Polling station No. 50 of Alwal MPTC issued 21 Andhey MPTC ballot papers from Serial No.2020 to 2040 from bundle No.1 and 12 Andhey MPTC ballot papers from serial No.2270 to 2280 and 2282 from bundle No.6. Totally 33 ballot papers of Andhey MPTC were issued to Alwal MPTC voters in polling station No.50 and they cast votes. The Returning Officer verified the ballot papers of other polling station Nos. 47, 48, 49, 51, 52 and 53 of Alwal MPTC and found correct.

Whereas, the report of the Collector & District Election Authority, Siddipet District reveals that, the election process in Polling Station No.50 of Alwal MPTC of Mirdoddi Mandal in Siddipet District, was vitiated due to issue of wrong ballot paper.

And whereas, the State Election Commission, after careful examination of the matter and taking all material circumstances into account, decided to re-notify fresh poll in Polling Station No.50 of Alwal MPTC in Mirdoddi Mandal in Siddipet district for MPTC elections only and synchronizing it for Phase-III of poll.

Now, therefore, in exercise of the powers conferred under article 243 K of the Constitution of India and Section 230 (1)(c) of Telangana Panchayat Raj Act, 2018 and Rule 6 of Rules relating to the conduct of election rules, 2018, the State Election Commission, hereby, declare the poll conducted in Polling Station No.50 of Alwal MPTC in Mirdoddi Mandal in Siddipet district on 06.05.2019 as void and direct that a fresh poll shall be conducted in Polling Station No.50 of Alwal MPTC, Mirdoddi Mandal in Siddipet district on 14.05.2019 from 7.00A.M to 5.00 P.M duly following the procedure prescribed under Telangana Panchayat Raj (Conduct of Elections) Rules, 2018.

The date of poll of Alwal MPTC in Polling station No.50 shall be informed to the contesting candidates of that MPTC and Political parties in writing and also to voters of Polling station No.50 of the said MPTC by tom-tom in that Polling area.

In this election, indelible mark shall be applied on the fourth finger of left hand.
