Whereas, in reference No. 1553/TSEC-PR/2019, dated 20.04.2019, the State Election Commission issued Notification for conduct of Ordinary Elections to MPTCs and ZPTCs in three phases in the State.

And whereas, the MPTC Aziznagar of Moinabad Mandal in Ranga Reddy District is notified for election in Phase-I.

And whereas, as per the election schedule notified in the Annexure-I appended to the Notification No. 1553/TSEC-PR/2019, dated 20.04.2019, the date of poll of MPTCs and ZPTCs notified in Phase-I of election is from 7.00 A.M to 5.00 P.M on 06.05.2019.

And whereas, in Lr.No.G1/Elections/2019, dated 06.05.2019, the Collector & District Election Authority, Ranga Reddy District reported that, 34 ballot papers of Kanakamamidi MPTC were issued to Aziznagar MPTC of Moinabad voters in polling station No.111 and they cast their votes.

Whereas, the report of the Collector & District Election Authority, Ranga Reddy District reveals that, the election process in Polling Station No.111 of Aziznagar MPTC of Moinabad Mandal in Ranga Reddy District, was vitiated due to issue of MPTC ballot papers pertaining to other MPTC.

And whereas, the State Election Commission, after careful examination of the matter and taking all material circumstances into account, decided to re-notify fresh poll in Polling Station No.111 of Aziznagar MPTC in Moinabad Mandal in Ranga Reddy district for MPTC election only and synchronizing it for Phase-III of poll.

Now, therefore, in exercise of the powers conferred under article 243 K of the Constitution of India and Section 230 (1)(c) of Telangana Panchayat Raj Act, 2018 and Rule 6 of Rules relating to the conduct of election rules, 2018, the State Election Commission, hereby, declare the poll conducted in Polling Station No.111 of Aziznagar MPTC of Moinabad Mandal in Ranga Reddy district on 06.05.2019 as void and directs that a fresh poll shall be conducted in Polling Station No.111 of Aziznagar MPTC of Moinabad Mandal in Ranga Reddy district on 14.05.2019 from 7.00A.M to 5.00 P.M duly following the procedure prescribed under Telangana Panchayat Raj (Conduct of Elections) Rules, 2018.

The date of poll of Aziznagar MPTC in Polling station No.111 shall be informed to the contesting candidates of that MPTC and Political parties in writing and also to voters of Polling station No.111 of the said MPTC by tom-tom in that Polling area.

In this election, indelible mark shall be applied on the fourth finger of left hand.


