Whereas, in reference No. 1553/TSEC-PR/2019, dated: 20.04.2019, the State Election Commission issued Notification for conduct of Ordinary Elections to MPTCs and ZPTCs in three phases in the State.

And whereas, the MPTC Kadirepad of Pangal Mandal in Wanaparthy District is notified for election in Phase-III.

And whereas, as per the election schedule notified in the Annexure-I appended to the Notification No. 1553/TSEC-PR/2019, dated 20.04.2019, the date of poll of MPTCs and ZPTCs notified in Phase-III of election is from 7.00 A.M to 5.00 P.M on 14.05.2019.

And whereas, in Lr. No. C/291/2019, dated 14.05.2019, the Collector & District Election Authority, Wanaparthy District reported that, Totally 87 ballot papers of Penchikalpadu MPTC were issued to Kadirepad MPTC voters in polling station No.64 and they cast votes.

Whereas, the report of the Collector & District Election Authority, Wanaparthy District reveals that, the election process in Polling Station No.64 of Kadirepad MPTC of Pangal Mandal in Wanaparthy District, was vitiated due to issue of another MPTC ballot paper.

And whereas, the State Election Commission, after careful examination of the matter and taking all material circumstances into account, decided to re-notify fresh poll in Polling Station No.64 of Kadirepad MPTC in Pangal Mandal in Wanaparthy district.

Now, therefore, in exercise of the powers conferred under article 243 K of the Constitution of India and Section 230 (1)(c) of Telangana Panchayat Raj Act, 2018 and Rule 6 of Rules relating to the conduct of election rules, 2018, the State Election Commission, hereby, declare the poll conducted in Polling Station No.64 of Kadirepad MPTC in Pangal Mandal in Wanaparthy district on 14.05.2019 as void and direct that a fresh poll shall be conducted in Polling Station No.64 of Kadirepad MPTC, Pangal Mandal in Wanaparthy district on 17.05.2019 from 7.00A.M to 5.00 P.M duly following the procedure prescribed under Telangana Panchayat Raj (Conduct of Elections) Rules, 2018.

The date of poll of Kadirepad MPTC in Polling station No.64 shall be informed to the contesting candidates of that MPTC and Political parties in writing and also to voters of Polling station No.64 of the said MPTC by tom-tom in that Polling area.

In this election, indelible mark shall be applied on the fourth finger of left hand.
