NOTIFICATION

Whereas, in reference No. 1263/TSEC-PR/2019, dated: 29.05.2019, the State Election Commission issued a Notification for conduct of elections to the offices of Member, Co-opted, President and Vice-President of Mandal Praja Parishad.

And whereas, as per the election programme notified, the special meeting for conduct of elections to Member, Co-opted, President and Vice-President of Mandal Praja Parishad was scheduled on 07.06.2019.

And whereas, certain Collectors and District Election Authorities and CEO, Ranga Reddy ZPP reported to the State Election Commission that, the elections to the certain Member, Co-opted of Mandal Praja Parishads were not held.

And whereas, Sub-Rule (8) of Rule 5 of rules relating to the TPR conduct of indirect election rules, 2018 stipulates that – *If, for any reason, the election of Member (Co-opted) is not held on the date fixed as aforesaid, the meeting for the election of the President or Vice-President shall not be held and the matter shall be reported to the State Election Commission for fixing another date for holding election of Member (Co-opted), President and Vice-President of Mandal Praja Parishad.*

Now therefore, in exercise of the powers conferred by Article 243-K of the Constitution of India and Sections 196, 197 and 147 (11) (as amended) of Telangana Panchayat Raj Act, 2018 (Act No. 5 of 2018), and Rules relating to the Telangana Panchayat Raj Conduct of election of Member, Co-opted, President and Vice-President of Mandal Praja Parishad and Members, Co-opted, Chairperson and Vice-Chairperson of Zilla Praja Parishad Rules, 2018 issued in G.O.Ms.No. 27, PR & RD (PTS.III) Dept., dtd: 19.05.2018 (as amended), the State Election Commissioner, Telangana, hereby, directs the Collectors and District Election Authorities of the Districts indicated in the Annexure-I to authorise a Gazetted Officer of the Government for conduct election of **Member (Co-opted), President and Vice-President of their Mandal Praja Parishads** indicated in the Annexure - I in accordance with the procedure laid down in the said rules and specifies the schedule for the elections to the said offices in the Annexure – II appended to this Notification.

The term of the newly elected body will commence from the date to be notified by the State Election Commission separately.

1. If for any reason the election of Member (Co-opted) is not held on the said date, the special meeting for election of President and Vice-President of Mandal Praja Parishad shall not be convened and the matter shall be reported to State Election Commission immediately.

2. After completion of election of Member (Co-opted), if for any reason the election of President and Vice-President of Mandal Praja Parishad is not held on the date fixed above i.e., 15.06.2019, it shall be held at 3.00 PM on the next day, i.e., 16.06.2019 whether or not it is observed as holiday by the Mandal Praja Parishad concerned (as per second proviso under Section 147(11) of Telangana Panchayat Raj Act, 2018). If the President or Vice-President election could not be conducted on the next date also, the matter shall be reported to the State Election Commission for fixing another date for holding election (as per sub rule (3) of rule 8 of Rules relating to the conduct of indirect elections).
