In exercise of the powers conferred under Articles 243-K and 243-ZA of the constitution of India, Section 9, 10 and 12 of the Greater Hyderabad Municipal Corporation Act, 1955 (Act II of 1956) read with Section 14 of Telangana Municipal Corporation Act 1994 (Act 25 of 1994) and Rules 3 and 5 of the Telangana Municipal Corporations (Preparation and Publication of Electoral Rolls) Rules, 2001, the State Election Commissioner, Telangana hereby Notifies **15.02.2019** as the date for publication of electoral rolls of the Municipal Corporations as indicated in the Annexure appended to this notification.

2. Under Section 12 of the Greater Hyderabad Municipal Corporation Act, 1955 and Rule 3 of the said Rules, the State Election Commissioner, Telangana hereby, Authorizes the Commissioners of Greater Warangal Municipal Corporation in Warangal Urban District and Khammam Municipal Corporation in Khammam District for Preparation and Publication of the electoral rolls of concerned Division. The persons so authorized shall prepare the Electoral Rolls as indicated in the Annexure appended to this notification as specified under Rule 3 of the said Rules duly adopting the latest Assembly electoral rolls published with reference to 01.01.2018 as the qualifying date and publish them as required under Rule 5 of the said Rules along with Notice in Form-I specified thereunder.

3. Under Rule 4 of the said rules, the State Election Commissioner, Telangana also hereby directs the Municipal Commissioners of Greater Warangal Municipal Corporation and Khammam Municipal Corporation to prepare the electoral rolls of the said Divisions as indicated in the Annexure appended to this notification in the same format and language /languages as the Assembly electoral rolls. The details of the polling areas shall be indicated on the title page.
