In case of casual vacancies, the Ward jurisdiction carved out during the Gram Panchayat Elections held in January, 2019 and in case of MPTCs the Ward jurisdiction carved out during MPTC Elections held in May, 2019 shall not be changed. Any inclusion/deletion of names in Gram Panchayat Electoral Rolls, shall be added/deleted to the concerned ward only.
