The State Election Commissioner, Telangana further, hereby, authorizes the Municipal Commissioners concerned under Sub-section (1) of Section 195-A of Telangana Municipalities Act, 2019 and Rule 3 and 5 of the said Rules for Preparation and Publication of Photo Electoral Rolls (MERs) of wards of Municipalities / Municipal Corporations indicated in this annexure appended to this Notification with reference to 01.01.2022 as qualifying date duly adopting latest draft Assembly Constituency Electoral Rolls (ACERs) in toto.

Under Rule 4 of the said Rules the State Election Commissioner, Telangana also hereby directs that, the ward wise Municipal Electoral Rolls of the Wards of Municipalities / Municipal Corporations indicated in Annexure shall be prepared in the same format and language / Languages as Assembly Electoral Rolls. The details of polling areas shall be indicated on the title page of the ward Municipal Electoral Rolls.

After publication of ward wise Municipal Electoral Rolls as specified above i.e., on **21.04.2022**, any inclusions, deletions or corrections if any ordered in the ACERs under continuous updation U/s 22 or 23 of RP Act, 1950 **upto the date of Election Notification** under Section 195-A of Telangana Municipalities Act, 2019, shall be obtained by the concerned Commissioners of Municipalities / Municipal Corporations as the case may be from the EROs concerned and shall be carried out in the Electoral Rolls of the concerned wards of the ULB, till the date of election Notification issued by the State Election Commission.
