NOTE:-

1. If for any reason the election of Member (Co-opted) is not held on the said date, the special meeting for election of President and Vice-President of Mandal Praja Parishad shall not be convened and the matter shall be reported to State Election Commission immediately.

2. After completion of election of Member (Co-opted), if for any reason the election of President and Vice-President of Mandal Praja Parishad is not held on the date fixed above i.e., 24.09.2020, it shall be held at 11.00 AM on the next day, i.e., 25.09.2020 whether or not it is observed as holiday by the Mandal Praja Parishad concerned (as per second proviso under Section 147(11) of Telangana Panchayat Raj Act, 2018). If the President or Vice-President election could not be conducted on the next date also, the matter shall be reported to the State Election Commission for fixing another date for holding election (as per sub rule (3) of rule 8 of Rules relating to the conduct of indirect elections).
