Under Rule 4 of the said Rules the State Election Commissioner, Telangana also hereby directs that, the Photo Electoral Rolls of the Municipalities indicated in the Annexure, shall be prepared in the same format and language/ Languages as Assembly Electoral Rolls. The details of polling areas shall be indicated on the title page.
